## TOGAF® Enterprise Architecture Practitioner certification exam

A candidate can proceed to the Practitioner certification exam if he has successfully passed the TOGAF® Foundation certification exam.

## Practitioner criteria:

- 8 questions / 90 min. (English as a Second Language – 135 minutes)
- The questions are designed in the form of prepared scenarios, which must be assessed and one selected out of a possible 4 answers for using the TOGAF® framework
- Open Book: YES
- Proctor Supervision: YES
- Candidates must achieve min. 60% of correct answers (24 points out of 40)
